P16/058 Declarations of interest: none.

P16/059 Public consultation time: Mr Stone (applicant in relation to P15/S2778/FUL 2A

Grove Road) provided the committee with a list of recommended tree species for planting on potential sites around the village to offset any loss of trees from the proposed development site. Mr Stone proposed to liaise further with the parish council, South Oxfordshire District Council, landowners and his landscape architect to agree suitable sites and tree species. This was welcomed by the committee.
