004.01/P17/S1160/HH. The demolition of an existing ground floor side garage with a flat roof to be replaced with a two-storey side extension with an integral ground floor garage with bedrooms above and a single-storey rear extension at 12 Park Close RG4 9RY.

Following discussion, the committee unanimously resolved to recommend approval of the application, subject to confirmation of adequate parking provision being made for the proposed development.
