#### FLOODING ON HORSEPONDS ROAD, GALLOWSTREE COMMON FMS REF: 820017

Thames Farm: As you have already seen in the press. SODC have lost their request to take the decision of the Planning Inspector to approve the Thames Farm application to the Court of Appeal. That is effectively the end of the road as far as opposition to the application goes.
