- P19/040 Public consultation time. Contributions made during discussion of item 141.01.

041.01/P18/S2631/FUL Erection of 25 dwellings together with associated landscaping, and public open space to the rear of 44 Kennylands Road Sonning Common. After hearing the views of interested residents and discussion it was resolved to register 'No Objections' with the following conditions being applied on approval:

- That the hours of work on the site be strictly limited to 08.00 to 17.00 on weekdays and 08.00 to 13.00 on Saturdays with no Sunday working.
- That the fencing to be erected behind Nos 46 to 52 Kennylands Road be specified as post and rail and that the hedge planted there should be of native species including some evergreens or hedging such as beech the retains its leaf in winter.
- That provision is made in perpetuity for the hedges and fences all around the development to be professionally managed and maintained.
- That the appeal for a 30 home development be abandoned.
