P19/100 Apologies for absence: Mrs Godfrey, Mrs Diwell.

P19/101 Declarations of interest: none.

P19/102 Public consultation time: none present.

P19/103 New applications:

103.01/P18/S4167/HH. The construction of a single-storey side extension at 1A Baskerville Road RG4 9LS.

Members resolved that they had no objections to the side extension but were surprised and disappointed that the extension had been built prior to planning permission being granted and wished for these comments to be taken into account by SODC.

103.02/P18/S4001/HH. The erection of a summer house to the rear of 17 Peppard Road RG4 9SS.

Members resolved that they had no objections to the application but wished for SODC to take into account the impact of the development on 19 Peppard Road, which it overlooked; concerns over potential residential use of the summer house; and the scale of the proposed development. A site visit by a planning officer was recommended.
