P20/125 Apologies for absence: Mrs Lewis, Mr Coombs.

P20/126 Declarations of interest: none.

P20/127 Public consultation time: none present.

P20/128 New applications:

128.01/P19/S4371/HH. A garage conversion and back/side extension at Small Mead, 6 Wood Lane RG4 9SL.

After discussion members decided to recommend this application for refusal. They considered it to be an over-development of the site given that permission had been already granted for a new dwelling in the rear garden of the existing dwelling. Members were also concerned about the adequacy of car parking and garden space on-site.

128.02/P19/S4594/HH. The construction of a double-storey extension at 23 Beech Rise RG4 9TJ.

After discussion members decided to fully support the application.

128.03/P19/S0012/FUL. The removal of condition 5 on application P16/S1603/FUL for the conversion and extension of a stable block into a one-bedroom self-contained unit of holiday accommodation at Pond Farm, Blackmore Lane RG4 9NU.
