Appendix C

Recommended process for the handover of Memorial Park from contractors Aurora and Sport and Play to Sonning Common Parish Council.

The recommended process, as approved by the Parks and Recreation Committee (minute PRC 21/048.02) on Monday 11 October 2021, is as follows:

- 1. Sport and Play (S&P) to advise Aurora when they consider that the snagging list has been completed, including the removal of stones to an acceptable and safe level.
- 2. Aurora to inform the Parish Council (PC) and the Memorial Park Working Party (MPWP) that this stage has been reached.
- 3. Aurora to arrange an initial walk-around of the site involving Mrs Pearman, Mrs Snowden (MPWP); Mr Jacobs (S&P); and Mrs Varnes (Parish Office) to check the suitability of the site for handing over to the PC.
- 4. Following this initial walk-around of the site a further site inspection to be arranged by Aurora and conducted among Mr Jacobs (S&P); Mrs Pearman, Mrs Snowden (MPWP); Mr Cann and Mr Rawlins (Sonning Common Parish Council); and Mr Collings and Mrs Varnes (Parish Office). This inspection will be to check the group's satisfaction with the completed groundworks and to agree any remedial work, including timescales.
- 5. The handover of the site to take place once any remedial works have been completed to the satisfaction of the full group detailed above.
- 6. S&P's insurance arrangements to remain in place until the handover; the PC's insurance arrangements to take over upon the handover.
- 7. The maintenance contract to be agreed between S&P, Aurora, Mrs Varnes and Mrs Snowden.
- 8. Outstanding invoices to be settled thereafter and Aurora's responsibilities to be discharged.
