## SCPC Decision paper 2022.05

## **Subject: Memorial Park next steps**

Proposer: Ms Boorman

Meeting date: 20 June 2022

#### **Decisions proposed:**

- 1. Council will endorse the opening of the park as early in July 2022 as is feasible with a target of it being no later than 22 July for the school holidays, subject to the normal undertakings that the Council Office manage such as contract management and ensure are in place, such as Insurance etc.
- 2. Council will confirm that its remit for managing and operating the park is limited to:
  - a. Providing a properly maintained, clean and safe recreation space for use by people of all ages.
  - b. Providing, booking, collecting and accounting for fees for the hire of the polymeric surfaced MUGA and or other parts of the site.
  - c. Levying appropriate charges on individuals/organisations that wish to make regular use of the open facilities for fee earning activities such as exercise classes or 'boot camps'.

This remit does not extend to the provision or storage of portable equipment that may be used by hirers of or players on any of the park's surfaces at this time.

#### **Situation**

Significant progress has been made towards completion of the Memorial Park site by Sport & Play and of the new play area within it by Kompan. Both contractors should be able to allow us to use the facilities early in July.

The facilities should include:

- the hireable Multi Use Games Area (MUGA)with a polymeric surface booked initially by using the halls booking system
- the open MUGA and the 3rd tarmacked area
- the tracks around the site
- the new children's play area
- the main grassed plateau.

The new footpath from Farm Close will be open and there will be signage which will provide give information graphically to be accessible to all.
