24/023	Public Question Time: Mr Kedge addressed the Council concerning the proposed CIL Policy and his concerns that it was giving one Committee all the power and that it should be amended. Mr Kedge also commented on the uses of CIL money and that it can be spent on maintenance. Mr Robinson commented in reply that all recommendations from the Finance Committee will go to full Council for approval.
	Mr Rinta-Suksi asked the Council for more information about the proposed solar lights at Memorial Park. Mr Rawlins explained the plan to have solar up lights fitted around the track. Mr Rinta-Suksi asked if a survey had been done amongst the residents as he could not see the benefit of up lights and that it was not the best way to spend the Council's money.
